The Group–IV Service Recruitment Notification No 19/2022 has been issued on 01/12/2022 and the written examination was held on 01/07/2023.

Certificate verification for the candidates picked up in the ratio of 1:3 (1:5 for PwD candidates) was taken up from 20/06/2024 to 31/08/2024, 27/10/2024 to 28/10/2024, 04/11/2024 & 05/11/2024, 08/11/2024, 09/11/2024 and 10/11/2024.

After completion of certificate verification, and receipt of sports merit list from the Committee of Secretaries to Government, 8084 candidates have been provisionally selected on 14/11/2024.

In the provisional notification published on 14/11/2024, the selection of 59 candidates have been withheld for various reasons such as caste verification pending from district collectors, ex-servicemen status verification pending, personal court cases on the candidates, candidates submitted custodian certificates instead of originals etc.,

After receipt of original certificates / clarifications sought the result of 33 candidates is hereby released.

The Provisional Selection of 33 candidates is subject to outcome of pending Court Orders, if any and is published subject to following conditions

- 1. That success in the examination confers no right to appointment unless the appointing authority is satisfied after such enquiry as the case may be as considered necessary, that the candidate having regard to his/her character and antecedents is suitable in all respects for appointment to the service.
- 2. That the candidate is found physically fit for the post.
- 3. That the candidate should produce such original certificates as required in accordance with the rules/notification.
